Instructions for Petition Circulators

<u>Who can sign the petition?</u> Any registered voter who intends to vote in the Republican Primary Election on March 20, 2018 and who lives in Champaign County can sign the petition. Each person should sign only the petitions of one candidate for County Executive. A person signing this petition should not sign petitions for any other political party.

<u>*Who can be a Circulator?*</u> A circulator is a volunteer who requests signatures from registered voters on a petition. Anyone who is 18 years or older (or 17 years old and registered to vote in Illinois) and a United States citizen may circulate this petition.

Requesting Signatures for the Petition

Have the person sign their name and fill in the street address and city, town or village where they are registered to vote. When requesting signatures, keep the following rules in mind:

- 1. A person must be registered to vote in order to sign the petition.
- 2. A person must live in Champaign County.
- 3. A person may only sign the petition one time.
- 4. A person can only sign the petition for one candidate for County Executive, and only for candidates affiliated with the Republican Party.
- 5. Never let a person sign for any other person.

<u>Circulator Instructions: When you are done with a petition sheet</u>

- 1. Go to a notary public (your bank may have one, or we can find one for you) and fill in the space near the bottom of the page called the "Affidavit or Circulator" with YOUR NAME and ADDRESS.
- 2. Sign your name on the line "Signature of Circulator/Person Making this Affidavit" IN FRONT OF the notary public.
- 3. The notary public will then sign and stamp/seal the page.
- 4. You must fill in a circulator's affidavit and get a notary to sign EACH page you circulate.
- 5. Do NOT fill in the page number.
- 6. Send the **ORIGINAL** completed page(s) to:
